1. NOTICE OF RE-TENDERING

Key Reason for Re-tendering:

- **Scope & Design Revisions:** Material changes and structural design updates occurred in the project scope and operational requirements, resulting in substantially revised Bills of Quantities (BQs).

Note: Any Bid Securities or bonds submitted under the re-tendered tender will be released/returned to bidders. Previous submissions will not be considered, and bidders must submit fresh proposals. **Bidders who had paid for the retendered tender will need not to pay for the new one if they wish to participate.**
